# For GEON PERFORMANCE SOLUTIONS, LLC HEALTH AND WELFARE PROGRAM

This is a summary of the annual report of the GEON PERFORMANCE SOLUTIONS, LLC HEALTH AND WELFARE PROGRAM, EIN 84-3122624, Plan No. 501, for period 01/01/2022 through 12/31/2022. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

GEON PERFORMANCE SOLUTIONS, LLC has committed itself to pay certain selfinsured Medical, and Short-term Disability claims incurred under the terms of the plan.

### **Insurance Information**

The plan has contracts with DELTA DENTAL OF OHIO, EYEMED VISION CARE ON BEHALF OF THE FIDELITY SECURITY LIFE INS. CO., FEDERAL INSURANCE COMPANY, RELIASTAR LIFE INSURANCE COMPANY, BEHAVIOR MANAGEMENT SOLUTIONS, IMPACT SOLUTIONS, and LINCOLN NATIONAL LIFE INSURANCE COMPANY to pay Dental, Vision, Life Insurance, Long-term Disability, Accidental Death and Dismemberment, Employee Assistance Program, Business Travel Accident, Critical Illness, Hospital, and Accident claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2022 were \$1,208,179.

Because they are so called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending 12/31/2022, the premiums paid under such "experience-rated" contracts were \$375,723 and the total of all benefit claims paid under these contracts during the plan year was \$270,542.
